Sponsorship Chair now vacant.

Nominations committee would like to endorse Don's suggestion for Evelyn King (from his committee) Unanimously approved

The new Committee Chairs need to be voted on by the community.

We will wait until the Training Chair is determined to send out email ballot to the community.

Proposal of Fee Increase:

Done some feasibility studies.

It's been \$110 for pilgrims and servants for about 10 years

The median fee was \$160 for a dozen communities in the Southeast.

We are not losing money because of the fewer walks but instead are trying to rent out King's Retreat when it is not in use by NGWTE.

Eric is talking to other groups about our fees. Some of the groups have to pay transportation costs for motor coaches, renting a camp, etc.

We don't have those costs. But we do have maintenance and utilities

Trying to make it this increase incremental and pretty conservative at this point.

Might be incremental but as long as it's justified, we should be okay raising it in the future if needed.

Ginny submits for discussion that we do a non-refundable deposit so there is some skin in the game. Jeanette - last season we did have 1 sponsor with questionable sponsorship. He sponsored a lot of people and none of them showed.

Martin Conner - Maybe implement a time frame where you don't receive a deposit back.

Issue: some people don't want to pay PayPal, some don't like sending checks. Some sponsors wait and pay at Send Off.

IT/Treasurer: We finally got access into PayPal and we're working on getting it through Venmo through widgets on the website.

Don't think the deposit's a terrible idea. But we should reach a decision on the payment increase tonight and then we continue to discuss the idea of a deposit.

Tony and Mark are fixing the PayPal link.

Proposal is to begin Spring 2024, increase pilgrim and team fees from \$110 to \$125.

Bobby Butler proposed

Andy 2nd

Voted - approved

If someone signs up in the next several weeks for Spring 2024 or if they've already paid but can't attend this fall, they are grandfathered in at current rate.

November 3rd is the date we can change it on the website and on the application.

Transition of ministry manager support:

Ginny has been graciously and tenaciously owning that role.

She would be glad to train somebody on it.

Please start thinking about who might be able to do it.

Ginny and Martha Lee Sanders both had data base experience

A successor would need to understand how a database works

The person should be on the Technology committee
