**CALLED TO ORDER:** Martha Lee started the meeting at 7:03 PM. Robin Ward opened with a prayer and devotion.

**MINUTES:** Martha Lee discussed the minutes for the March 2021 meeting. Hilary Berman made a motion with a second by Ginny Sternberg to approve the minutes as posted. We voted and all were in favor of approving the Minutes for March 2021.

**TREASURER'S REPORT – Bobby Whirley**—Absent, no report this month.

## Old Business:

# 1. Task Force Update – Dave Wilkins –

Dave reported that things are beginning to open up as of 4/8. He also said that things are looking hopeful but will need to be reviewed again at the end of the month when the executive order is updated. He referenced the following email.

Attached (on our website) is the current Governor's Executive Order as of 3-31-21. I have also included screen shots of both Georgia DPH and Pandemics Explained. Please note Pandemics Explained does not show as favorable as the Georgia DPH graph.

With cautious optimism I would like to say this is all great news and we are heading toward life as we knew it, but I am not ready to go there just yet. Most all the restrictions that keep us from having a weekend are now gone or somewhat watered down. Of course, there are many rules and guidelines to follow when we proceed.

Please note Governor Kemp stated yesterday when he announced this, that all would be reevaluated at the end of April. At that time, we will find out if we have acted responsibly enough to continue forward with this newfound freedom. Your input and comments are welcome.

## 2. Procedure Update Sub-Committee - Martha Lee Sanders-

The committee is actively reviewing the needed reports for a weekend and working on an excel spreadsheet that will be used for these reports. The next step will be to update documentation.

## New Business:

## 1. Facilities – Dave Wilkins –

• Dave discussed the need to improve the air quality at King's Retreat. He presented four different options, but the facilities committee does not feel that two of them are feasible. One of the options is to add a Makeup Air function to the current systems, but the systems do not currently have enough tonnage to be effective. Facilities feels the best option is to install an Ionizer Air Purifier for all 17 HVAC Systems. Estimated Cost \$13,800.00. This Ionizer Air Purifier will clear the air at KR of Covid-19, cold and flu viruses, odors, and any other bacteria. They also recommend that as we replace a HVAC unit in the future, we will upgrade 15% in tonnage, and add a makeup air function.

Dave made the motion that we install the Ionizer Air Purifier for all current HVAC Systems, and as we replace HVAC units at Kings Retreat, we will increase the tonnage by 15%, and add the Makeup Air System. Kendel Nickens seconded, and the motion was approved.

- White House Remodel Update: The White House's foundation needs stabilization. We currently have funds that have been donated by several reunion groups to KR for remodeling the bathrooms in the White House. Dave will reach out to Bobby Whirley to find out which Reunion Groups have made these donations to ask them if we can use these funds along with existing funds to repair the foundation of the White House. Dave has a report and study that was performed on the White House Foundation and will forward to all Board Members by email for review and he will be available to answer any questions via email. This repair cost is \$24,502.40 and will take 3 to 4 days to complete foundation repairs. Dave requested to hold on this motion until Bobby has had time to review data and finances. Also, Mark Wyssbrod will make a video to add to the Loveletter and Facebook to raise funds from our Community using new donation program.
- This week a Reunion Group of 12 is donating time and materials to replace all gutters on the White House. Also, this week Hardscaping will be added to the front of the White House.
- Dave also brought up internet connectivity issues at King's Retreat. Internet access is being added to the White House. Also, there has been an issue with overloading the internet in the main building and this will be addressed by changing the Wi-Fi password for each walk. This will be handled through the tech servant.

## 2. Fund Development Status/Update – Mark Wyssbrod-

- Kindful has been integrated and they have kicked off the first campaign. Mark shared that the community has made donations over \$8,000.
- Mark has prepared two new videos staring Gwen Hamill in both. In the video titled *Do you miss me?* Gwen shares with our community how much she misses each one of us in the NGWTE community and encourages the community to make donations for Kings Retreat. Mark will work on a cover letter for the video, and it will be sent out soon. The 2<sup>nd</sup> Video prepared is also staring Gwen and is titled *Do you miss Kings Retreat?* This video invites individuals and/or

reunion groups to visit on Tuesdays to help with current projects and repairs and includes reminders about upcoming KR Workdays. Tara will post this video on our NGWTE Facebook page.

- In May Mark will work on a new campaign for donations for the White House.
- Mark Wyssbrod made a motion for persons that made exceptionally large donations to invite them to spend the night at the White House on April 30, 2021. They will also provide a special dinner, music, and campfire, and invite a Spiritual to give a short devotion. Tara Thompson 2<sup>nd</sup> this motion, and all in attendance also approved.

## 3. Ministry Manager Member Information – Ginny Sternberg/Martha Lee Sanders

Martha Lee and Ginny explained that Ministry Manager does not allow those with "member" rights (versus board or leadership rights) to view other members' contact information, such as address, email, and phone number. This prevents 20,000 in our community from connecting with other members. Martha Lee has asked us to brainstorm for a solution.
